Our objective is the environmental performance continuous improvement. While managing our activities we take into consideration compliance to local, regional and national laws as the minimum standard to reach. Our environmental targets are regularly reviewed so to ensure that our actions effectively carry out our environmental policy. They are:

- Regard significant environmental impacts and aspects of our manufacturing processes, applying an operating Environmental Management System in our plant;
- Ensure that environmental issues are properly evaluated and taken into consideration when making key decisions regarding supply chain, processes and new products development;
